National Coordinator for Preparedness



- A coordinating mechanism should be established at national level
- Appointed by the Government
- Responsible to coordinate the preparedness activities at national level

National Coordinating Mechanism Responsible to:



- Ensure that roles and responsibilities are clearly specified and understood
- Coordinate the hazard assessment
- Coordinate and ensure consistency among emergency arrangements of all response organizations
- Ensure consistency among requirements for emergency arrangements, contingency plans and security plans of operating organizations
- Ensure that appropriate training and exercise programmes are in place, coordinated and evaluated
- Coordinate communication with the public at the planning stage

National Coordinating Mechanism



- Subsequent to an emergency:
 - Coordinate analysis of the emergency
 - Analysis of emergency response
- One single national authority
 - e.g. Disaster management organization
 - An inter-agency mechanism composed by national authorities

National and Regional Officials



- Governmental authorities responsible for planning and response at national (or regional) level
- Usually perform tasks that do <u>not</u> need to be implemented urgently in order to be effective, such as:
 - longer term protective actions
 - support of local officials in the event that their capabilities are exceeded

Local Officials



- Governmental authorities and support agencies responsible for:
 - Immediate support to the operator and
 - Prompt protection of the public in the vicinity
- Include:
 - Civil emergency services
 - Police
 - Fire fighting and
 - Medical personnel
- It may include officials from different States, if the facility is near the border (EPC V)

Local and National Officials



- Establish and maintain arrangements for preparedness and response
- **Demonstrate effectiveness** of emergency arrangements
- **Coordinate** the off-site response with the on-site response, ensure **harmonization** of response within the national system

Legislative Framework on EPR



- Should be established at national level for
 - Effectively governing the preparedness and
 - Response at all levels
- Roles and responsibilities in preparedness and response should be clearly defined:
 - Decision making
 - Implementation of early and urgent protective actions
 - Implementation of long term protective actions
 - Warning the public in the affected areas, and
 - Keeping the public informed

Infrastructure for EPR



- All response organizations must have the capabilities for adequate response
 - Human
 - Financial
 - Other resources
- Meet the infrastructure requirements that apply to their assigned roles

Dual Role of the Regulatory Body



- As REGULATOR
 - To regulate, authorize and control facilities and activities in the nuclear field
- As RESPONSE ORGANIZATION
 - To provide advice and expert services on EPR at national level
 - To coordinate with the National Coordinating Mechanism

Regulatory Body as Regulator



- Establish regulations
 - EPR requirements for operating organizations
- Authorize
 - Establish an authorization system
 - Provide reasonable assurance for adequate EPR arrangements
- Verify
 - Establish an inspection system
 - Check the compliance of EPR arrangements for all licensees
 - Systematic evaluation of on-site exercises

Regulatory Framework on EPR Establishing Regulations



- The Regulatory Body
 - Develops regulations with requirements for operating organizations
 - The Regulatory Body's mandate is usually limited to licensees
- Other authorities (under National Coordinating Mechanism)
 - Usually set and maintain requirements for the national emergency response
 - Regulatory Body supports the development of the national emergency response framework

Regulatory Body as Response Organization



Preparedness

Provide support to and coordinate with other competent authorities

Response

- Advise the government and competent authorities
- Provide expert services
- As stipulated in the national emergency response framework
- This role may vary within the Member States
- Off-site notification point
- Consequence assessment
- Technical advice on:
 - Facility status, evolution and prognosis
 - Protective actions for workers and public

Regulatory Body as Response Organization (cont.)



- Public information
- Radiation monitoring
- On-scene response (EPC IV)
- Again, the response role varies within the Member States

The Operating Organizations



- Establish and maintain arrangements
 - On-site preparedness and response for facilities or activities under their responsibility
- Demonstrate that emergency arrangements are in place for
 - An effective response on the site
- Coordinate and integrate the on-site arrangements
 - With those existing at local and national level

Coordination Within the National System



- Arrangements and protocols for operational interfaces
- Arrangements to develop and harmonize tools, procedures or criteria for use in the response to nuclear or radiological emergency
- Arrangements to harmonize assessments of contamination, doses and radiation induced health effects and any other relevant assessments made in a nuclear or radiological emergency


Coordination at International Level



- Arrangements and protocols with other States to:
 - Coordinate early notification, data and information exchange
 - Public information
 - Protective actions
- Special arrangements for :
 - Early notification and
 - Information exchange for States with areas in category V

Key Points





- A National Coordinating Mechanism should be established
 - Responsible with co-ordination at national level of all emergency preparedness activities
- Regulatory Body has dual role:
 - As regulator
 - As response organization
- Main responsibilities of all response organizations:
 - Establish and maintain arrangements for EPR
 - Demonstrate effectiveness of arrangements
 - Coordinate within the national system
